The Bradley Arant Boult Cummings, LLP Annual Diversity Scholarship

The Law Firm of Bradley Arant Boult Cummings LLP (“BABC”) generously commits to the funding of scholarships each year to promote the education of well-qualified law students who reflect the diversity of the legal marketplace and who are traditionally underrepresented in the legal profession.

BABC will award two scholarships to two deserving students. A \$10,000 scholarship will be awarded to a student in his or her second year of law school, and a \$5,000 scholarship will be awarded to a student in his or her first year of law school. These scholarships will be available to law students attending ABA accredited law schools in the United States. The scholarships will be paid directly to the students or to their law schools.

In connection with receiving the scholarship, recipients will be required to clerk in one of BABC’s seven offices for at least six weeks of the summer after the scholarship is awarded. BABC will do its best to honor the scholarship recipient’s first choice for office placement but maintains the right to make the final decision.

The deadline for applying for the scholarships is September 15, 2011 for second-year law students and February 15, 2011 for first-year law students. Applicants who are interested in the scholarships should submit an application, resumé, official law school transcript, two letters of recommendation (optional) and a personal statement (LIMIT TO 750 WORDS) discussing (a) the importance of diversity in the legal profession and (b) the way(s) in which the applicant’s receipt of the scholarship would further BABC’s desire to improve diversity in the legal profession. In addition, the personal statement may also be used to apprise the Firm of any personal, work or other circumstances that the applicant believes the Firm should consider. In addition to academic qualifications, BABC may consider other factors including, but not limited to, involvement in community activities, financial need, and significant work and personal achievements.
